Refund Policy

Cancellations made at least 15 days from the start date of the program will receive a complete refund - less the processing fee. Cancellations made 7 days from the start date of the program will receive a 50% refund. There are no refunds for programs cancelled LESS than 3 days prior to the scheduled date of the program.

Make-Up Classes and Transfer Policy

Make up classes and transfers will be accommodated as long as there is room in the class. If your child is visibly sick or carrying a high temperature on the day of the class, please keep your child at home! We will make up the class at the next opportunity.

Cancellations

Dismissal Policy
